Minutes

The review of ALCs are almost complete and they will be forwarded to colleges for distribution to departments in advance of University Assessment Day on March 19th.

University Assessment Day, scheduled for March 19th is being developed (see next page).

The USFSP strategic plan (Points of Focus) which was approved by the USFSP Campus Board and which was forwarded to USF for approval by the Board of Trustees stalled temporarily due to a board member question. The USF Board of Trustees felt it prudent that USFSP's plan be reviewed in the context of USF's strategic plan. The board determined that USF's Academic Affairs Management Council (AAMC) could provide this type of review. The item was added to the AAMC's next regularly scheduled meeting and their review of the document at that meeting resulted in minor suggestions which will be incorporated into the document and which will be sent back to the USF Board of Trustees for final approval at their meeting in April.

Additional Discussion Item

It was discussed by the PEBC that the longer the strategic plan finds itself in review, the more difficult it becomes for the committee to fulfill its charge—namely, its responsibility for institutional effectiveness.

One item that came up for discussion was planning for summer school sessions. At issue was the notion that the colleges may not have not received sufficient guidance for planning summer sessions in the context of planning for the next academic year. Would summer offerings be reduced or could colleges offer summer courses that paid for themselves? It was agreed that this topic required further review. Julie Jakway, the Budget Director agreed to take this matter through to the appropriate regional chancellors for their consideration.
